14) In the event that either party must employ the services of an attorney to enforce any provision of this agreement, the hiring party hereby agrees to pay all costs of enforcement including reasonable attorney's fees and court costs. The provisions of this agreement shall be governed by Texas law. Any action arising from this contract or the acts contemplated herein shall be brought only in Lubbock County, Lubbock Texas and the hiring party hereby waives venue to any other county or state the parties so contract and agree.
